

Association fence. We all get a little
fired up for issues/events that are close
to the heart, and this was no exception
on both sides. Please understand that
this fence is Association responsibility.
Part of your HOA dues go towards
maintaining this fence, therefore it
cannot be used for advertising of any
sort.

It would be a large unnecessary expense should damage occur and it is against the covenants to use it for personal use. Technically the covenants state that no signs except for a realtor for sale sign shall be erected on any lot - meaning the small yard signs are also breaking the covenant.

They simply have an obligation to uphold the covenants and do their best to make decisions based on those covenants. We greatly appreciate your cooperation when you are approached about a violation.
